FINAL JUDGMENT AND PERMANENT INJUNCTION

On June 27, 2008, the parties appeared by and through their attorneys, and announced a settlement of all claims and causes of action asserted in this matter. In accordance with the terms of the agreement, the Court hereby enters the following judgment:

1. Plaintiff Johnson will pay Steven Sessions, Inc. and Steven Sessions a down payment of Ten Thousand Dollars \$10,000.00, and will execute an eight year note for an additional Forty-five Thousand Dollars (\$45,000.00), at market rate interest, payable quarterly beginning three months following the down payment, which shall be due July 27, 2008, in settlement of any damages, attorney's fees and costs incurred by the Sessions defendants as a result of the claims and causes of action alleged in the lawsuit.

2. It is further ORDERED that Timothy S. Johnson, his agents, employees, and all persons acting in concert with him, are hereby enjoined from directly or indirectly soliciting the business of, or accepting business from, the following list of clients and prospective clients of Steven Sessions, Inc., for a period of twenty-four (24) months following March 8, 2008, when he resigned his employment with Steven Sessions, Inc.: Aptia; Celovoke; Insight; Lakehills; Windham Builders; BVSCU; Houston Chronicle; Micro News Network; NSI Upstream; Prime Communications; Prosser; Texas Brain Institute; and WNS.

Except as otherwise specified in this judgment, all claims and causes of action asserted in this lawsuit by either side is hereby dismissed. All costs of court not otherwise awarded shall be borne by the party incurring them. Relief not expressly granted herein is denied.
